SERVING INSTRUCTIONS:

Important! Cut Frozen with Hot Knife.

1. Remove the cake from the package while still frozen.
2. For best results, **cut cake into required portions while frozen, using a sharp knife dipped in hot water.**
3. Cover and return unused frozen portions to the freezer immediately.
4. Thaw sliced cake portions in the refrigerator (<5°C) for approximately 30 minutes before serving.

Sugar, carrots (16%), wheat flour (thiamine), canola oil, egg, neufchatel cheese [milk, cream, salt, vegetable gum (410), lactic acid, starter culture], margarine (vegetable oil), walnuts, pineapple, glucose syrup, raising agents (sodium bicarbonate, 450), thickener (1412), cinnamon, salt, cocoa, vegetable gums (414, 415), emulsifiers (vegetable- 471, 475, soy lecithin), citric acid.
